DESE Update: New Structured Learning Time Regulations

ABRSC School Committee Meeting December 17, 2020

Our Priorities (Identified Spring 2020)

- Safety and health are our top priorities.
- We will keep plans realistic for all stakeholders: students, families, staff and community.
- We will create warm and welcoming environments in our schools that prioritize connections with and among students and staff.
- We will support students' social-emotional well-being.
- Equity will remain at the core of our work as we plan for students.
- Our focus is on students as learners and individuals, not just about unfinished teaching and learning.
- Communication is critical to maintaining trust.

November 2020	- Superintendents complete learning time survey for DESE
December 2020	- DESE proposed new learning time regulations (12/9) - Board of Education adopts new regulations (12/15)
January 2021	- Expected Implementation of new regulations (1/19)

Important Terms

Synchronous Learning: learning that is directed by a teacher and that happens in real time with other students such as during live, whole-class instruction, and small group work.

Asynchronous Learning: learning that occurs on a student's individual time and at their own pace.

NEW - Live Instruction: the total of in-person instruction and remote synchronous instruction combined.

<u>Structured Learning Time:</u> The total of all learning time, including live instruction and asynchronous learning combined, whether students are working in person or remotely.

DESE Student Learning Time Regulations - 603-CMR 27.00

Important Terms (as defined by DESE)

<u>Hybrid Model</u>: A District is considered in a "Hybrid Model" if that is the predominant learning model used by students (even if some students opt for remote learning only)

Remote Model: A District is considered in a "Remote Model" if that is the predominant learning model used by students (even if some students are learning in person)

ABRSD:

- ABRSD is considered to be in a Hybrid Model and is subject to these requirements, unless we receive a waiver from DESE
- If our schools transition to remote learning for a period of time, ABRSD would then be subject to the requirements under a Remote Model

Impact of Changes to Regulations

For ABRSD (Hybrid Model):

- Required daily "live" check-in for all students
- 35 hours "live instruction" for all students

For Remote Models:

- Daily "synchronous" instruction required for all students
- 40 hours "synchronous" instruction for students over 10 day period



Potential Strategies to Increase "Live" Time

1-6 (need 3 hours over 10 days)

- Increase assistant time to "zoom" with students on remote days
- Students "Zoom" into some combination of morning meetings/read alouds/afternoon check-in

7-12 (need 6 hours over 10 days)

- Directed Studies (7-8) or Advisories (9-12) as possibilities for daily "live" check-in
- Students "Zoom" into some or all classes to increase live instructional time
- Lengthen school day/ reduce passing times

Notes:

Not a complete list of possibilities - for illustrative purposes only

All options will have benefits, drawbacks, challenges to implement mid-year - some may not be feasible

• Survey Stakeholders (students, families, educators) about current experiences and preferences

Possible Outcomes/Changes to Hybrid Plan

- Addition of daily "live" check in for all students in grades 7-12 on remote days
- Addition of remote synchronous learning time K-12
- Application for DESE Waiver of Learning Time Requirements
- Some combination of these outcomes
